Strictly abolish or revise laws and regulations that are not necessary to cause undue burdens on the public or open up opportunities for corruption such as procurement, licensing, approval and requesting for government services, which The government has many processes, time-consuming, repetitive and costly for government and the public sectors to improve and implement laws to cover the protection, suppress corruption and misconductAnd having complex benefits in the public sector at all levels, this is an urgent national agenda.

Than Sawiwittaya School recognizes the importance of the intent of managing with integrityAnd it is of the view that the school must have all government policies that the school has to take seriously and to carry out the actions mentioned, Dhansawiwittaya School has declared its intention to administer the administration of integrity for the personnel of the Dansawiwittaya School to adhere to the following.

Composition as follows

๑.**Policy** the school operates with the following elements: Policy Danswiwittaya School would like to set up a policy for the administration of Dan Sawiwittaya School with a declaration showing the intention to administer with honesty "in order for the personnel of the Dansawittaya School of all levels, all levels. Setting standards and operating guidelines as follows

- ๒.๔ Adhere to the ๖ principles of good governance
 - ๑) Rule of law - Stick to the law , order , government orders that are required by law
 - ๒) Moral - Adhere to the right and the virtue, behave himself as a good example
 - ๓) Responsibility principles - Realize about performing their duties and responsibilities in performing their tasks to the best of their abilities in each person's position and duty.
 - ๔) Principle of appreciation - Personnel use resources economically and for the best benefit and worth, taking into account the interests of the people most important.
 - ๕) Uphold the principle of transparency - Strictly adhere to transparency in working with transparency, disclose useful information ,straightforward, no conflicts of interest ,there must be no corruption and can check the results of operations.
 - ๖) Based on the principle of participation - Working to listen to information and express opinions from all stakeholders, including the public.
- ๒.๕ Adhere to the Nine Core Values of Ethical Standards for Political Positions and Government Officials of the Office of the Ombudsman, As follows.
 - ๑) Sticking to morality and ethics.
 - ๒) Have a good conscience, honesty and responsibility.
 - ๓) Taking national interests over one's own interests and no conflicts of interest.
 - ๔) Standing for doing what is right Fair and legal.
 - ๕) Serving people with speed Courteous and non-discriminatory.

- ๖) Providing accurate and complete information to the public including not distorted facts.
- ๗) Focusing on the achievement of the standard maintenance work is of quality, transparency and accountability.
- ๘) Adhere to democracy with the King as Head of State.
- ๙) Adhere to the professional code of conduct of the organization.

๓. Target group government officials, government officials and all permanent employees.

๔. Operation method to drive the will of management with integrity Honestly achieve the policy Measures and requests as follows.

๔.๑ The announcement of the intention of the honest administration of Dan Sawiwittaya School informs all personnel.
